



My Health Record - Healthcare Provider Registration

Access via contracted service provider (CSP)

Step 1 – Register for a PRODA account

PRODA (Provider Digital Access) is a method of authentication to provide users with access to government services online - <https://proda.humanservices.gov.au>

As the person registering for My Health Record you will become your organisation's Responsible Officer (RO). The RO has other functions in relation to the organisation's interaction with the HI Service and the My Health Record System Operator. Your organisation will be required to comply with the My Health Record system [participation obligations](#).

PRODA registration requires three forms of identification from the following list. Australian passport, Medicare card, Australian driver's licence, ImmiCard, Australian birth certificate, Australian Visa and foreign passport, Citizenship certificate, Certificate of registration by descent.

Password hint: cannot include more than one special character. Complete the registration and log in.

Step 2 – My Health Record Seed Organisation Registration

Healthcare providers and administrators can manage the My Health Record registration process via Health Professional Online Services (HPOS). Once you are logged into PRODA, click **Health Professional Online Services (HPOS)** from the list of services.

If this is your first time using PRODA...

You will be prompted to enter your healthcare identifier (i.e. HPI-I, HPI-O or RO/OMO number). You will then be prompted to accept the terms and conditions, set your email address, and set your notification preferences. It is recommended that you select **Immediate notification for each new correspondence**.

Once your PRODA and HPOS are linked...

From within the **Health Professional Online Services** tile, choose either **Link Identifiers** to link your PRODA account to your HPI-O or **Go to Service** to register your organisation. Follow the prompts.

The first two tabs identify the organisation and your details. The third tab allows you to nominate an Organisation Maintenance Officer (OMO).

If you are not listed on your organisation's Australian Business Register record, you may need to upload evidence to your online application.

The following documents may be uploaded. A full list of documents is included in the **Organisation Details** tab of the online application.

- ◆ Certificate of company registration from ASIC
- ◆ Notice by registrar of Australian Business Register
- ◆ Business bank statement
- ◆ Lease agreement or Rates notice

- ◆ Other document (eg a statutory declaration [Your CEO/owner should sign a letter on organisation letter head addressed "To whom it may concern", stating that "Full name and role" is authorised to act on behalf of the organisation and to commit the business".] Upload in the Documents section in HPOS.)

Submit the form, your process will end with a Pending status. The **HPOS Mail Centre** will notify you when the registration is complete.

Step 3 – Link your HPI-O with your CSP

Before completing this step you will need to contact your CSP to obtain their CSP number.

From the HPOS home screen, click the **My Programs** tile, then click the **Healthcare Identifiers and My Health Record** tile, and then **Healthcare Identifiers - Manage existing Records**. Select **My organisation** details from the HI Services available list. Select your organisation. From the Organisation snapshot screen, select the **CSP Links** tab and then **Add** to add the CSP. Enter the CSP number to find your CSP, and then select **Confirm**. This will link your organisation's HPI-O number to your CSP.

Step 4 – Linking My Health Record System

From the HPOS home screen, click the **My Programs** tile, then click the **Healthcare Identifiers and My Health Record** tile. Then click **My Health Record - Register Organisation**.

Select **Manage Authorisation Links**

Select **Add/Update Links** from within the Registered Organisation box.

Enter the CSP number, **submit** and **confirm**.

Note the active and linked CSP number.

Step 5 – Add healthcare professionals' HPI-Is to your clinical information system

Contact your CSP for guidance as required.
